## SERVICE LETTER #35

**SUBJECT:** Questionable Flamability of Burgundy Upholstery Fabric.

**MODELS AFFECTED:** M-5-210C Series, Serial Numbers 6113C thru 6122C, 6126C, 6129C, 6130C, 6132C, 6136C, 6138C, 6142C, 6149C, 6152C, 6156C, 6159C, 6161C, 6166C, 6171C, 6173C and 6178C; M-5-235C Series, Serial Numbers 7007C, 7008C, 7010C, 7016C thru 7018C, 7020C, 7023C thru 7025C, 7031C, 7033C and 7034C.

**COMPLIANCE:** Immediate compliance recommended.

**AUTHORITY:** This Service Letter is FAA approved.

**BACKGROUND:** There is a possibility that some upholstery material used in the subject airplanes does not meet the flame resistance requirements of CAR 3.388(a).

The material in question is Uniroyal Naugahyde AL-38 Burgundy (Dark Red) cloth-backed vinyl.

**CORRECTIVE ACTION:** If your aircraft does not have this upholstery material in the cabin, so indicate on the Service Letter Compliance form and return it to us.

If this upholstery material is installed in your airplane, immediately placard your aircraft against smoking with a "No Smoking" sign prominently displayed in full view of all occupants.

If you desire to remove this placard in the future, Maule Aircraft Corporation will furnish, free of charge, materials for fireproofing the subject material, so that said placard can be removed.

Either way, fill out the attached Service Letter Compliance Record and return it to Maule Aircraft Corporation as soon as possible.
